## Copyright Transfer Agreement

for publication by Midwifery Today, Inc. (MT).

Dear Contributor(s):

Thank you for submitting your Contribution for publication. In order to expedite the publishing process and enable MT to disseminate your work to the fullest extent, we need to have this Copyright Transfer Agreement signed and returned to us as soon as possible. If the Contribution is not accepted for publication, this Agreement shall be null and void.

### A. Copyright

1. The Contributor assigns to MT, during the full term of copyright and any extensions or renewals of that term, all copyright in and to the Contribution, including but not limited to the right to use the Contribution and the material contained therein in electronic and print editions of *Midwifery Today* magazine, other publications of MT, on midwiferytoday.com, in derivative works throughout the world, and to publish, republish, transmit, sell, distribute and to license or permit others to do so in all languages and in all media of expression now known or later developed.
2. Reproduction, posting, transmission or other distribution or use of the Contribution or any material contained therein, in any medium as permitted hereunder, requires a citation to the MT publication and an appropriate credit to MT as Publisher, suitable in form and content as follows: “[Title of Article], [Author], [Publication Title] [Volume/Issue] Copyright © [year] Midwifery Today, Inc.”

### B. Retained Rights

1. Notwithstanding section A above, the Contributor or, if applicable, the Contributor’s Employer, retains all proprietary rights other than copyright, such as patent rights, in any process, procedure or article of manufacture described in the Contribution, and the right to make oral presentations of material from the Contribution.

### C. Other Rights of Contributor

MT grants back to the contributor the following:

1. The right to share with colleagues print or electronic “preprints” of the unpublished Contribution, in form and content as accepted by MT for publication. Such preprints may be posted as electronic files on the Contributor’s own Web site for personal or professional use, or on the Contributor’s internal university or corporate networks/intranet, or secure external Web site at the Contributor’s institution, but not for commercial sale or for any systematic external distribution by a third party (e.g., a listserv or database connected to a public access server). Prior to publication, the Contributor must include the following Notice of Copyright: (a) On the preprint: “This is a preprint of an article accepted for publication in [Publication Title] Copyright © [year] Midwifery Today, Inc.” ; and, (b) After publication of the Contribution by MT, the preprint notice should be amended to read as follows: “This is a preprint of [Title of Article as Published], an article published in [Publication Title] [Volume/Issue], pp [Page Numbers] Copyright © [year]”

Midwifery Today, Inc.” and should provide an electronic link to the MT Web site, located at the following URL: <http://www.midwiferytoday.com/>. The Contributor agrees not to update the preprint or replace it with the published version of the Contribution without the written consent of MT.

2. The right, without charge, to photocopy or to transmit online or to download, print out and distribute to a colleague a copy of the published Contribution in whole or in part, for the Contributor’s personal or professional use, for the advancement of scholarly or scientific research or study, or for corporate informational purposes in accordance with paragraph D2 below.
3. The right to republish, without charge, in print format, all or part of the material from the published Contribution in a book written or edited by the Contributor.
4. The right to use selected figures and tables, and selected text (up to 250 words) from the Contribution, for the Contributor’s own teaching purposes, or for incorporation within another work by the Contributor that is made part of an edited work published (in print or electronic format) by a third party, or for presentation in electronic format on an internal computer network or external Web site of the Contributor or the Contributor’s employer. The abstract, if any, shall not be included as part of such selected text.
5. The right to include the Contribution in a compilation for classroom use (“course packs”) to be distributed to students at the Contributor’s institution free of charge or to be stored in electronic format in data rooms (“electronic reserve rooms”) for access by students at the Contributor’s institution as part of their course work and for in-house training programs at the Contributor’s employer.

D. Contributions Owned by Employer

1. If the Contribution was written by the Contributor in the course of the Contributor’s employment (as a “work-made-for-hire” in the course of employment), the Contribution is owned by the company/employer which must sign this Agreement (in addition to the Contributor’s signature), in the space provided below. In such case, the company/employer hereby assigns to MT, during the full term of copyright, all copyright in and to the Contribution for the full term of copyright throughout the world as specified in section A above.
2. In addition to the rights specified as retained in section B above and the rights granted back to the Contributor pursuant to section C above, MT hereby grants back, without charge, to such company/employer, its subsidiaries and divisions, the right to make copies of and distribute the published Contribution internally in print format or electronically on the Company’s internal network. Upon payment of the Publisher’s reprint fee, the institution may distribute (but not resell) print copies of the published Contribution externally. Although copies so made shall not be available for individual resale, they may be included by the company/employer as part of an information package included with software or other products offered for sale or license. Posting of the published Contribution by the institution on a public access Web site may only be done with MT’s written permission, and payment of any applicable fee(s).

E. Government Contracts

1. In the case of a Contribution prepared under U.S. Government contract or grant, the U.S. Government may reproduce, without charge, all or portions of the Contribution and may authorize others to do so, for official U.S. Government purposes only, if the U.S. Government contract or grant so requires. (Government Employees: See note at end.)

F. Copyright Notice

1. The Contributor and the company/employer agree that any and all copies of the Contribution or any part thereof distributed or posted by them in print or electronic format as permitted herein will include the Notice of Copyright as specified in section C.1. above.

G. Contributor's Representations

1. The Contributor represents that the Contribution is the Contributor's original work. If the Contribution was prepared jointly, the Contributor agrees to inform the co-Contributors of the terms of this Agreement and to obtain their signature(s) to this Agreement or their written permission to sign on their behalf. The Contribution is submitted only to MT and has not been published before, except for "preprints" as permitted above. (If excerpts from copyrighted works owned by third parties are included, the Contributor will obtain written permission from the copyright owners for all uses as set forth in section A above, and show credit to the sources in the Contribution.) The Contributor also warrants that the Contribution contains no libelous or unlawful statements, does not infringe on the right or privacy of others, or contain material or instructions that might cause harm or injury.

H. Additional Provisions

1. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original for purposes of enforcement, and shall be returned to MT at PO Box 2672 Eugene OR 97402, by Fax to (541) 344-1422, or by e-mail to [editorial@midwiferytoday.com](mailto:editorial@midwiferytoday.com). Facsimile copies or images of signature pages shall be equal to original signatures. This agreement is contractual in nature and shall be construed under the laws of the State of Oregon with venue in Lane County, Oregon. In any action arising under this agreement the prevailing party shall be entitled to reasonable attorney fees and costs.

**U.S. Government work**

Note to U.S. Government Employees:

**U.K. Government work (Crown Copyright)**

Note to U.K. Government Employees:

The rights in a Contribution by an employee of a U.K. Government department, agency or other Crown body as part of his/her official duties, or which is an official government publication, belong to the Crown. In such case, the Publisher will forward the relevant form to the Employee for signature.
